ADDING MUSIC VIDEO WORKSHOP

CLICK "EVENT OPTIONS" BUTTON On your "EVENT ATTENDEES" page to the right is a blue "EVENT OPTIONS" BUTTON **Music video Workshop (\$95.00)**

Dancer Must be registered for the event to participate. If you received a MVW certificate at the regional event you are invited to participate in this workshop.

Enter in the number of dancers participating in the Music Video Workshop.

List each dancer name in the note section.

All dancers can be listed in one box.

This is not a scholarship and the fee still applies.

This is a limited invite. Once we hit the max number we will sell out the workshop.

ADDING BANQUET TICKETS

CLICK "EVENT OPTIONS" BUTTON On your "EVENT ATTENDEES" page to the right is a blue "EVENT OPTIONS" BUTTON Additional Banquet Tickets (\$110.00)

All REGISTERED teachers (directors) & dancers receive their banquet ticket with the registration.

DO NOT purchase additional banquet tickets for PAID REGISTERED participants.

ONLY purchase additional banquet tickets for observers, family, and friends attending with REGISTERED teachers or dancers.

ADDING SCHOLARSHIPS

On your "EVENT ATTENDEES" page click the green "Add Scholarship" BUTTON

STARDOM AWARD click on green "Add Scholarship" button

If you received this award during one of the 2024 regional cities you receive a free workshop to the national event in 2024. <u>Includes one banquet ticket.</u>

CURRENT TEEN COMPANY MEMBERS

click on green "Add Scholarship" button

All current 2024 Teen Company Members receive complimentary workshop fees to the national event. Includes one banquet ticket.



2023 REIGNING ICONS of the YEAR

All reigning 2023 Icons of the Year receive complimentary workshop fees to the national event. <u>Includes one banquet ticket.</u>

Complimentary ICON Solo fee.

All of these fees will be zeroed out by the HC office. Nothing to do at this time.

ENTERING SOLOS

SOLO (\$130.00)

When you enter a solo you choose SOLO to compete in the open Solo Challenge at the national Finals. *Dancers do not need to be qualified at a regional event to enter in a national solo.*

ICON SOLO (\$165.00)

When you enter an ICON solo you choose ICON SOLO to compete in the Icon of the Year competition. *This is an invite only competition.* You must have received an Icon title or Icon runner up award in one of the 2024 regional cities in order to participate.

YES, you can compete the same solo in both the Icon and solo competitions.

Yet they must be entered twice (solo & icon solo)

NO SOLO ICON (\$165.00)

You may still participate in the ICON of the YEAR opening number and not do a solo in the competition. The Solo fee of \$165.00 still applies to cover the costume and choreographers' fees. With this option, dancer will not be eligible to win ICON of the YEAR.

AUDITIONS

2025 TEEN COMPANY AUDITIONS online form to fill out - COMING SOON!

A separate email will be sent for dancers to fill out online for their Teen Company auditions.

This is an invited audition. Dancers must meet all requirements in order to participate, view requirements on HC Teen Company page on our website. Dancers must have received an invite in one of the 2024 regional cities to participate. You DO NOT need to be registered for the NF event to audition for Teen Company.

Nothing to do while registering. No additional fee to audition.

Bring 4x6 photo to audition. Photocopy is OK.



FAME AWARD - MTA AGENCY AUDITION

This is an invited audition and you will check in onsite at the event.

Dancer must have received an invite in one of the 2024 regional cities to participate.

Dancers that received the ICON Title Winner and/or Runner Up are automatically invited to participate.

Dancer MUST BE registered for the NF event to audition.

There will be an onsite check in at the event prior to start time on the day of audition.

Nothing to do while registering. No additional fee to audition.

You do not need to bring a photo or resume.

PHOTOSHOOTS

HOLLYWOOD ACTION SHOOT online form to fill out - **COMING SOON!**

This is an invited photoshoot and you must have received an invite in one of the 2024 regional cities to participate in the photoshoot.

Dancer MUST BE registered for the NF event to participate.

A separate email will be sent for dancers to fill out online for their photoshoot.

Dancer will also check in onsite at the event on the day of shoot.

Nothing to do while registering. No additional fee to participate.

HOLLYWOOD MAKEOVER PHOTOSHOOT online form to fill out - COMING SOON!

This is an invited photoshoot and you must have received an invite in one of the 2024 regional cities to participate in the photoshoot.

Dancer MUST BE registered for the NF event to participate.

A separate email will be sent for dancers to fill out online for their photoshoot.

Dancer will also check in onsite at the event on the day of shoot.

Nothing to do while registering. No additional fee to participate.

HC SQUAD - COMING SOON!

This is an invite only performance and you must have received an invite in one of the 2024 regional cities to participate in the HC Squad event.

Dancer MUST BE registered for the NF event to participate.

Dancers will perform live on stage in a routine with Brooklyn Jai.

HC Squad rehearsal begins on July 1st.

The HC office will email registered dancers to confirm if they are participating.

Nothing to do while registering. No additional fee to participate.
